Intentions of the privacy, confidentiality and personal data entrusted to it. Within this basic obligation, the operator undertook to ensure adequate protection and use of personal data (sometimes also called " **personally identifiable information** "Or" **PII** '), The operator gained by collecting information through its Web site.

## 1. Consent to the processing of personal data

The operator is in some cases required to obtain consent to the processing of personal data in accordance with the regulations and laws (collectively " **Legislation on privacy** ").

In cases where consent is required by the legislation on protection of personal data, consent and detailed purpose for which and how your personal information will be processed, are presented in the form provided. Approval (sending) of this Operator you give your express consent to the processing of their personal data. Approval (sending) this form, you confirm that you operator informed of your rights under Part III regulations and under Part II of the Act concerning the processing of personal data, notably rights of the persons whose data are processed to access and verify your personal information, voluntarily provided personal data and the ability to require deletion of personal data. More detailed information about your rights in connection with OII are listed below. You also confirm the correctness and accuracy of your data.

Consent is granted for an indefinite period, but not longer than the time necessary to achieve the purpose of such processing. Your personal data will be processed exclusively within the range you specified above, within the scope of this privacy statement or the extent necessary to achieve the purpose of processing.

## 2. Collection and Use of Personal Data

### 2.1 What data we collect

Your personal information is obtained only on condition that they choose to provide, for example, so that we can contact you by email or phone when you choose to contact us via the contact form on our website. By sending personal data by operators you confirm that the operator may use your personal information in accordance with this Privacy Policy. Your personal information will not be used for any other purpose unless we get your consent or unless required or permitted by law.

### 2.2 Lawfulness of the processing of your personal data

The operator generally only processes personal data that are necessary to fulfill your request. If you need additional optional data, you will be informed at the time of collection.

*Slovak legislation enables us to process personal data if it is to such processing legal basis referred to in the Act. It also requires us to you pursuant to such familiar reasons. Your data will be processed by one of the following reasons:*

- *your consent : Sometimes we may ask for your consent to the processing of some of your personal data and we will process them only after your express consent. Your consent may be revoked at any time, just contact us at [smik@hyundai-steel.com](mailto:smik@hyundai-steel.com);*
- *Performance of the contract or pre-contractual procedure : In cases where contact us on the proposal to conclude a contract or in connection with a contract already concluded, we your personal information to process on this basis; or*
- *legal obligation : Processing of personal data is necessary for the task carried out in the public interest or in the exercise of public power entrusted to the operator, such as record keeping for tax purposes or disclosure of a public authority.*

operator collects sensitive personal information only if the persons concerned voluntarily provide such information and give us consent to the processing of this privacy statement or if permitted by law or professional standards. Sensitive information includes personal data on race, ethnic origin, political opinion, trade union membership, but a similar religious beliefs, physical or mental health, sexual life or criminal record data. ## 2.3 Automatic collection of personal data

In some cases the operator and its service providers use cookies and other technologies to automatically collect certain information when you visit our sites. Collecting this information allows us to improve the performance, usability and effectiveness of the website of the Operator and measure and evaluate the effectiveness of our marketing activities.

### 2.3.1 IP addresses

IP address is a number assigned to your computer whenever you connect to the internet. It allows computers and servers to recognize each other, and communicate. IP addresses from which visitors connect website may be recorded for the purposes of security and IT system for diagnostic purposes. These data may also be used in aggregate form to fruition trend analysis websites and their performance.

### 2.3.2 cookies

Cookies can be placed on your computer or device with Internet access whenever you visit our website. Cookies enable our website to remember your computer or device and serve several purposes.

Cookies may be necessary to provide the necessary functionality.

Although most browsers automatically accept cookies, your browser settings, you can choose to receive or to not receive cookies (often located in the Tool Options or Settings). You can also delete cookies at any time from your device. We would like to point out, however, that in case of not accepting cookies, you may not be able to use all features of our website.

Below is a list of types of cookies on our website:

- *cookie to determine ci visitor saw notification on the use of cookies (Cookieconsent\_status). Cookie expires exactly one year and at re-visit is not extended;*
- *session cookie [used records the user logged into the CMS - refers to visitors who fill out a form and if there is a validation error when sending (eg. the wrong answer*

- *antispam question) and a form remembers the previously completed data and site visitor does not need to fill them again]. A cookie expires after you close your browser; cookie regarding the set language (language version of the site) called FluentLocale, which is valid for 3 months and is automatically renewed each time the page is loaded.*

Cookies themselves do not enable us to check your e-mail address or any other way you identify.

### 2.3.3 Google Analytics

This page uses Google Tag Manager to call Google Analytics code. Analytics creates a cookie valid for 26 months and after re-visiting our website will automatically expire the cookie resets. All third-party cookies are generated through this external service to measure website traffic.

## 2.4 About children

The operator understands the importance of protecting the privacy of children, and particularly in the online environment. Our web site is not specifically designed and targeted at children under 16 years old. Our philosophy is that he never knowingly do not run collect information on persons aged under 16 and do not keep data on them, except in situations where it is a part of the contract. In this case, it is necessary to authorize the legal guardian of the child.

## 3 Sharing and transfer of PII

We do not share personal information with unidentified third parties, except as necessary to fulfill our legitimate professional and business interests, to process your requests and / or if required or permitted by law or professional standards. This includes the following group of persons:

- Our service providers An operator works with renowned partners, service providers and / or agencies who can handle your personal information on our behalf. The operator transferred personal data only to persons who meet strict standards for data processing and security. Only we share personal information that is necessary to provide the security functionality of the website and, if necessary to complete your request.

If permitted by legislation to protect personal data operator may share your PII with various companies, service providers or vendors acting on our behalf, and to improve compliance with your requirements. At the same operator may be transferred across borders certain OII another company belonging to the business group or the Operator, acting on our behalf. The operator may also store PII in accordance with other than your legislation. By providing PII online visitors to our web site, you agree to the transfer and storage of their PII outside, where they provide under any of the following cases:

- Changing the organizational structure or business transfer Operator An operator may provide PII to third parties in connection with the sale, transfer of the business;
- Courts, arbitration courts and other public authorities (hereinafter " **Public authorities** ") An operator can provide personal information in order to comply with the requirements of public authorities or if it is obliged by laws of general application;

- audits An operator may provide personal data for audit purposes personal data and / or to investigate or review complaints in case of security threats.

The operator may also transfer certain personal data outside the EEA cooperating companies or company acting on its behalf for the purposes described in this privacy statement. The operator can store personal information outside the EEA. If you do, then this personal information will continue to be protected by means that we have agreed in the contracts with these organizations outside the EEA which are in the form approved by the European Commission. By providing personal information online, visitors agree to such cross-border transmission or storage of their personal data.

The operator does not sell PII to any third party. The operator also does not transfer PII that you provide us with any third parties for their marketing purposes.

#### 4 Options

You have several options on how to use the website of the Operator. In general you can say that if you visit the website of the Operator, you are not obliged to provide any PII to us, but if you want to contact us, our response can be contingent upon certain OII.

As mentioned above, if you do not want to set a cookie in your browser when you connect to our website, you can set your web browser to refuse all cookies or you reported any attempt to send a cookie to your computer. If you choose to reject all cookies, some parts of our website may not be fullyfunctional.

#### 5 access

If you provide the operator of personal data, you have the following rights:

- In most cases **Right of access and rectification:** You have the right to reasonable access to your personal information. The above is called that person's request for access to personal data. If you have committed to provide personal information, we will provide them free of charge. Before providing personal information we may require you to prove your identity and information needed to locate your data. If we treat your personal data that are inaccurate or wrong, you have the right to request their correction;
- **Challenge the process:** You have the right to challenge us processed personal data. If your personal data, we are not entitled to continue to use it, you have the right to erase data, especially if such personal data are stored long time, processing is prohibited or for any other reason folded the legal basis for the processing of your personal data.

#### 6 Security and data integrity

The operator has set up appropriate safety rules and security policy to protect personal data from loss, misuse, alteration or destruction. and respect the confidentiality of such information. We also try to ensure that your personal information only to businesses the necessary time to implement your request, or until the person concerned us, where the data are not request their deletion. Under all circumstances, you are entitled to your complaint to the Office for Personal Data Protection, which will deal with your request.

## **10 The rights of the persons concerned**

The person concerned has with regard to the processing of his personal data following rights:

- **right of access** to their personal data;
- **the right to repair** their incorrect, incomplete or outdated personal data;
- **the right to delete** their personal data (under the terms of the Regulations);
- **the right to limit processing** their personal data (under the terms of the Regulations);
- **the right to object to the processing of** their personal data (under the terms of the Regulations);
- **right to portability of their personal data** ( the conditions of the Regulations);

- **the right to complain to the supervisor** ie the Office for Personal Data Protection of the Slovak Republic.

NOTE: The data subject has **the right to object the processing of** their personal data, which is performed on the basis of a legitimate interest of the Operator. If the person concerned wishes to raise such an objection may do so through the contact person listed above.

In case the operator determines that a legitimate interest outweighs the rights and freedoms of the data subject may, in its processing of personal data continue. If the objection of the person recognized as legitimate, it may mean that the operator will continue its personal data processed for a given purpose.

The above rights are further specified in Articles 12 to 21 of the Regulation.
